**Memorandum of understanding

This Memorandum of Understanding (MoU) is entered into effect as of 12<sup>th</sup> April, 2015 (the "Effective Date"), by and between the Center for Biomedical Technology and Cell Therapy (Called Centre) McGill University (MU) which is a component of a state-supported institution of Higher Education located in Canada and the Barkatullah University Bhopal ("BU") which is an institution of higher learning located in Bhopal, India. MU and BU shall be known collectively as the "Parties" and singularly as a "Party".

**Recitals**

Whereas, cordial relation exist between MU and BU; and

Whereas, BU and MU have discussed mutual goals regarding academic opportunities for students and faculty of both institutions; and

Whereas, McGill Center and BU desire program(s) to be formalized for the benefit of faculty and students of their respective educational institutions;

Now, therefore, the Parties enter into this Memorandum of Understanding in order to memorize concept regarding Program(s).

## Understanding of the Parties

In view to make the Program(s) operational, the parties agree as follows:

### Article 1 (objective)

- A. To contribute further to the regional understanding between both countries, both cities (Canada, Montreal and India, Bhopal), and both parties (McGill Center and BU) through mutual cooperation programs.
- B. To establish and for furtherance of the collaboration between McGill Center and BU through academic exchanges in instructions, research, faculty exchange and development among the faculty and students of both institutions

### Article 2 (Responsibilities of Parties)

- A. Both parties commit themselves to concertize area of academic collaboration and to explore the financial resources to achieve a successful collaboration.

### Article 3 (Understanding of Parties)

- A. Parties understand and acknowledge that they are making a significant commitment to this collaborative effort. Accordingly, Parties agree to reach out for their best efforts on the design, implementation, and successful continuation of Program.
- B. This MoU shall remain effective from the date of execution until the end of the term of five(5) years, which may be extendable further for 5 years on mutual understanding of the two parties. Afterwards the MoU may be discussed for inclusion of areas of interests as per the requirements of the Society.
- C. The parties understand and acknowledge that this memorandum of understanding will provide the comprehensive and action oriented activities concerning the achievements.
- D. Parties understand that this program must support through its activities the mission of the McGill University and its vision; that the international program may not use the name and official seal of the McGill University or any of its components without the written consent of the Director or his/her designee. Similarly, the international program may not use the name and official seal of Barkatullah University or any of its components without the written consent of the Vice Chancellor or his/her designee; that the international program is subject to all policies and procedures of the University.








